

# Chippewa County Parks

## Terms & Conditions

Chippewa County parks are generally open the first weekend in May thru November 1. Reservations are generally accepted thru mid-September. Self-registration is from mid-September though October, weather permitting. Round Lake day-use park is open from Memorial Day thru Labor Day, 9 a.m. – 9 p.m. Otter Lake day-use park is generally open from May thru mid-September, 9 a.m. – 9 p.m.

### Camping Fees

*Site = \$18/night*

*Site with boat dock = \$4/night*

*Electricity = \$7/night*

*Reservation fee = \$5/site*

*Pavilion = \$15/day without electric*

### Dump Station Fees

*Camping Guest = \$2.00*

*General Public = \$6.00*

**Reservation Policies:** We begin accepting reservations on the first working day of the year. All reservations must be made a minimum of 10 days prior to park arrival date - three-night minimum, fourteen-night maximum per reservation - seventh night is free and is calculated for one reservation and on one site only—no exceptions. There is a \$5.00 reservation fee applied to **each** reservation - even when multiple reservations are made for consecutive days and/or for the same site. When a site has been reserved via the on-line website, it shall remain “reserved”, whether the party shows up to camp or not. Reserved sites cannot be sold at the parks. Check in and check out are both at 1 p.m.

**Electricity:** Electricity is optional on all sites. All sites have 20-30-50-amp service.

**Occupancy:** You are allowed one camper and one tent per site **or** two tents per site.

**Dump Fees:** Your dumping fees are not included with your reservation unless selected by the customer. Please deposit your payment in the collection tube located in the dumping area if not prepaid.

**Unreserved Sites:** Unreserved sites are sold by the park caretaker, first come, first served on the night you want to camp. **Reservations are not accepted by the caretaker.** Look for an empty site that does not have a reservation card posted at the front of it. You have to have a Camper’s Registration Card to make the site yours.

**Cancellation Policies:** All cancellations must be made online (via this website) at least 10 days in advance of scheduled park arrival date—no exceptions. Cancellation fee is \$15 **per reservation**.

**Occupancy:** Only one family or individual group allowed per campsite. **No more than 6 adults occupying one site.**

**Campsites & Trees:** No person shall disturb, deface, remove or destroy any trees, shrubs, plants or other natural growth; carve on any rocks, archaeological or geological features, signs, walls or structures; drive nails in trees; or move, injure or deface in any manner any structures including buildings, signs, fences, tables or other county property.

# Chippewa County Parks

## Terms & Conditions

**Campsite Parking:** No person shall park any motor vehicle outside the parking area designated at each campsite and not more than one motor vehicle is permitted at any campsite. Extra vehicles must be parked in designated parking lots.

**Parking Where Prohibited:** No person shall park, stop or leave standing, whether attended or unattended, any vehicle, obstruction or watercraft in any manner:

- To block, obstruct or limit the use of any road, trail, parking lot, boat landing or waterway;
- Outside of any area provided for such purposes when it is practical to use such areas; or
- Contrary to posted notice.

**Pets:** All pets must be kept on a leash, no longer than 8 feet, at all times. Never leave your pet unattended. Pets are prohibited in all beach areas, picnic areas and buildings. You are required to clean up after your pet. All rules regarding pets are strictly enforced to ensure enjoyment for all park visitors and guests.

**Horses:** No person shall ride a horse or have a horse in any county park without the authorization of the park attendant.

**Hunting & Trapping:** No person shall take, catch, kill, hunt, trap, pursue or otherwise disturb any wild animals or birds in any county park.

**Quiet Hours:** Each park observes quiet time after 10 p.m. Please respect your neighbor!

**Fires & Fireworks:** Fires are allowed in designated fire rings or grills only. Campfires may not be left unattended at any time! Fireworks are **not** permitted in any of our parks!

**Firewood:** Firewood is sold at the park for \$6.00/rick. Firewood brought into the parks from a distance further than a 25-mile radius of the park is prohibited. Firewood bought into the parks from a county other than Chippewa is prohibited.

**Firearms:** No person shall have in his/her possession or under his/her control, any firearm, air gun or gas operated gun unless the firearm, air gun or gas operated gun is unloaded and enclosed in a carrying case or any bow, crossbow, or slingshot. This subsection shall not apply to persons with a valid carry and conceal weapon permit issued pursuant to Wis. Stat., 175.60

**Personal Conduct & Nuisances:** No person shall indulge in parties, violent, abusive, indecent, profane, boisterous, unreasonably loud, or otherwise disorderly conduct under circumstances in which such conduct tends to cause or provoke a disturbance.

**Swimming Area Limits:** No person shall swim, wade or bathe within 50 feet of any boat landing unless inside the marked swimming area. No person shall swim beyond, disturb or molest a bathing beach buoy or marker in any swimming beach in any county park.
